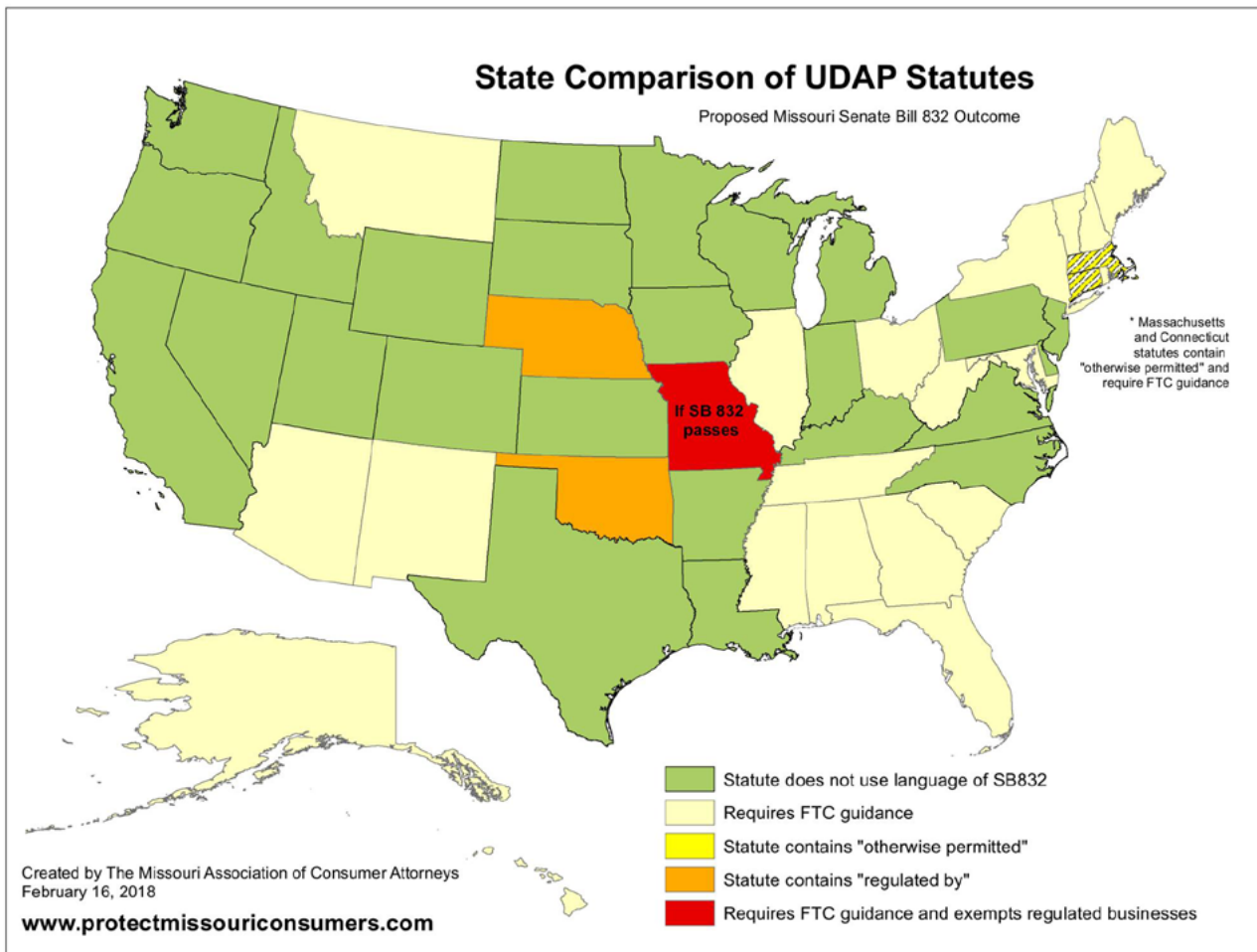
But that is about to change.

No other state in the nation has passed such a draconian bill. If passed, Missouri will stand alone.

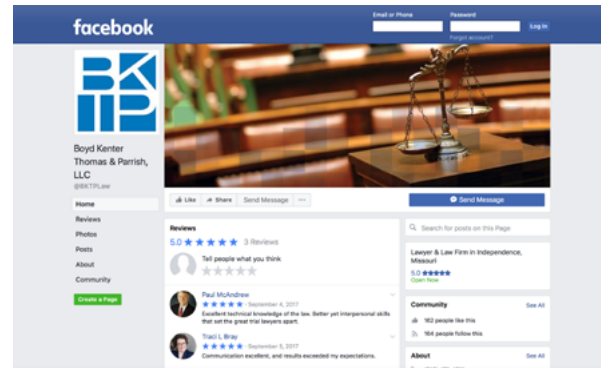
