Did You Know BKTP Can Represent You with a Product Liability Claim?

A product can be defective in several different ways, including design, manufacturing, and or because of inadequate warnings. A product liability claim means you are holding manufacturers, designers, assemblers, installers, distributors, and/or sellers of products liable for personal injuries suffered because of an unreasonably dangerous product.

If a defective product causes injury or death, the injured victim, or their survivors, may seek damages from responsible parties in court. If such a situation occurs due to dangerous and defective product, we will help in any way we can.





What NOT To Do If you Are Injured at Work

Workplace accidents can result in serious injuries, some of which will render you unable to return to work.

Attempting to file a Claim for Compensation on your own can lead to delays in medical care and payment of temporary compensation benefits. Navigating the legal landscape without the help of a lawyer could result in the loss of your benefits.

Common mistakes that people make, prior to hiring a lawyer, are:

1. Using sick leave to recover from a workplace injury when you qualify for temporary total disability (TTD) compensation
2. Counting on your employer to file the appropriate forms on your behalf (which they do not need to do)
3. Failing to provide your employer with notice of your injuries within 30 days of an injury
4. Failing to file the Claim for Compensation within the statute of limitations window (generally 2 years from your date of accident and injury)
